Camping Administrative Permit – Extended Stay

Effective September 25, 2020

Pursuant to County Ordinance 18-09, notwithstanding the other provisions of Section 3-17.01 of Chapter 17, of Title 3, when a legally established, permanent residence is destroyed by fire, flood, wind, landslide, seismic or volcanic activity, and/or any other natural disaster, the property owner may apply for an administrative permit to camp on private property in a recreational vehicle for a period not to exceed one year. The Planning Director and/or his or her designated representative may issue an extended permit provided that an approved domestic water and sewage disposal source is onsite and the Environmental Health Department has confirmed that any hazardous waste resulting from the disaster and presenting a risk to human health and safety has been cleared from the property. The permit shall be conditioned on the recreational vehicle being licensed and maintained in a readily transportable configuration, meaning it is transportable within four (4) hours either on its own motive power or towed by a light duty truck.

Siskiyou County Code (SCC) Section 3-17.01 – Camping on Private Property Outside Designated Campgrounds.

Effective November 15, 2017, it shall be unlawful and a public nuisance within the unincorporated areas of the County to camp or squat upon private property without a legally established residence, on private property that is outside of a designated campground, or on a property with other lawful entitlements to camp unless such person has been issued a permit to do so by the County Planning Division.
